



Update on the Cameron Gulbransen KIDS AND CARS Safety Act of 2007

Our bill now has 28 co-sponsors in the Senate and 27 co-sponsors in the House. The Commerce, Science and Transportation committee in the Senate unanimously approved S. 694 May 16th. The bill must now be considered by the full Senate.

S. 694: A bill to direct the Secretary of Transportation to issue regulations to reduce the incidence of child injury and death occurring inside or outside of light motor vehicles, and for other purposes.
